### ADVERTISEMENT FOR BIDS PHASE III - ENOREE WATER AND SEWER IMPROVEMENTS CDBG PROJECT NO. B-18-UC-45-0003 WOODRUFF-ROEBUCK WATER DISTRICT

**Receipt of Bids:** Separate sealed Bids for the construction of the Phase III - Enoree Water and Sewer Improvements project, CDBG Project No. B-18-UC-45-0003, will be received, by Woodruff-Roebuck Water District, at its administrative office located at 9890 US Highway 221, Woodruff, South Carolina, until 2:00 PM local time on February 14, 2019, at which time the Bids received will be publicly opened and read aloud.

**Project Description:** The work to be performed shall be accomplished in one (1) Division of work and shall consist of furnishing all materials, equipment and labor necessary for the installation of sewer system improvements as described below:

- **Sewer System Improvements:** Clearing of existing sewer right-of-way, cleaning and video of approximately 2,896 LF of existing gravity sewer mains, the installation of approximately 255 LF of 8-inch gravity sewer and 2 new manholes, installation of new / relocated residential service connections, installation and/or replacement of approximately 1,800 LF of existing 4-inch sewer service lines to 37 existing residences, the installation of new 4-inch cleanouts, sediment and erosion control facilities and other necessary appurtenances and associated tasks.

**Mandatory Pre-Bid Conference:** A mandatory pre-bid conference will be held at 10:00 AM on February 7, 2019, by the Woodruff-Roebuck Water District, at its administrative office located at 9890 Highway 221, Woodruff, SC. Representatives of the Owner, Engineer, and Spartanburg County will be present to discuss the project. ***All Bidders are required to attend the conference.*** The Owner's representative will transmit to all prospective bidders of record such addenda as may be necessary in response to questions arising at the conference.

**Project Funding:** The project is being funded via the Spartanburg County CDBG program and therefore bidders must comply with all applicable State and Federal requirements identified in the contract documents.

**Examination of Documents:** The Instructions for Bidders, Bid Form, Contract, Plans, Specifications, Bid Bond, Performance Bond and Payment Bond, and other contract documents may be examined at the following locations:

Bidding Documents are available on compact disc or thumb drives as portable document format (PDF) files for a non-refundable charge of \$75.00, including shipping. Alternatively, printed Bidding Documents may be obtained from the Issuing Office either via in-person pick-up or via mail, upon Issuing Office's receipt of payment for the Bidding Documents. The non-refundable cost of printed Bidding Documents is \$150.00 per set, payable to "Summit Engineering Group, Inc.". The date that the Bidding Documents are transmitted by the Issuing Office will be considered the prospective Bidder's date of receipt of the Bidding Documents. Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Issuing Office.

**Qualification of Bidders:** Bidders must be listed on the Engineer's record of attendance for the mandatory pre-bid conference. Bidders must also be on the Engineer's official plan holders list. Bidders must be legally qualified, on the date of the bid, under the provisions of the South Carolina Contractor's Licensing Law (South Carolina Code of Laws as amended on April 1, 1999, Chapter 11, Sections 40-11-10 through 40-11-428). Bidders must have a Contractor's classification of WL.

**Bid Security:** Bidders must deposit security with all bids. Security shall be in the form of a certified check or bid bond made payable to the Owner and shall be for an amount equal to not less than five percent (5%) of the amount of the bid. Provisions of the security shall be as described in the Instructions for Bidders.

**Bid Withdrawal:** No bid may be withdrawn within 90 days after the actual date of the opening thereof.

**Bidder's Rights:** Any prospective bidder, offer, or contractor or subcontractor who is aggrieved in connection with the solicitation of this contract may protest to Owner in accordance with Section 11-35-4210 of the SC Code of Laws, within 7 days of the date of issuance of the Intent to Award.

**Owner's Rights:** The Owner reserves the right to waive any informality or to reject any or all bids.
