**Project Description:** The work to be performed shall be accomplished in one (1) Division of work and shall consist of furnishing all materials, equipment, and labor necessary for the installation of water system improvements as described below:

- Installation of a new Booster Pump Station with two end suction split coupled pumps with VFDs
- Installation of an associated paved driveway and parking area
- Installation of approximately 750 linear feet of 16-inch water line/yard piping
- Installation, maintenance, and removal of erosion control facilities
- Other associated appurtenances for a complete and proper installation

Bidders must have a Contractor's classification of WL.

**Bid Security:** Bidders must deposit security with all bids. Security shall be in the form of a certified check or bid bond made payable to the Owner and shall be for an amount equal to not less than five percent (5%) of the amount of the bid. Provisions of the security shall be as described in the Instructions for Bidders.

**Bid Withdrawal:** No bid may be withdrawn within 90 days after the actual date of the opening thereof.

**Bidder's Rights:** Any prospective bidder, offer, or contractor or subcontractor who is aggrieved in connection with the solicitation of this contract may protest to Owner in accordance with Section 11-35-4210 of the SC Code of Laws, within 7 days of the date of issuance of the Intent to Award.
