Receipt of Bids: Separate sealed Bids for the construction of the Woodruff-Roebuck Water District Switzer Pump Station project, will be received, by Woodruff-Roebuck Water District, at <u>9890 US-221, Woodruff, SC 29388</u>, until 2:00 PM local time on Thursday, <u>February 13, 2025</u>, at which time the Bids received will be publicly opened and read aloud.

Project Description: The work to be performed shall be accomplished in one (1) Division of work and shall consist of furnishing all materials, equipment, and labor necessary for the installation of water system improvements as described below:

- Installation of a new Booster Pump Station with two end suction split coupled pumps with VFDs
- Installation of an associated gravel driveway and parking area
- Installation, maintenance, and removal of erosion control facilities
- Other associated appurtenances for a complete and proper installation

This is a Re-Bid of the October 15, 2024 Switzer Pump Station project. All previous bids were rejected, and the scope of the project was revised due to cost. Prior plan holders will be given an electronic set of plans via email.

Qualification of Bidders: Bidders must be on the Engineer's official plan holders list. Bidders must be legally qualified, on the date of the bid, under the provisions of the South Carolina Contractor's Licensing Law (South Carolina Code of Laws as amended on April 1, 1999, Chapter 11, Sections 40-11-10 through 40-11-428). Bidders must have a Contractor's classification of WL.

Bid Security: Bidders must deposit security with all bids. Security shall be in the form of a certified check or bid bond made payable to the Owner and shall be for an amount equal to not less than five percent (5%) of the amount of the bid. Provisions of the security shall be as described in the Instructions for Bidders.

Bid Withdrawal: No bid may be withdrawn within 90 days after the actual date of the opening thereof.

Bidder's Rights: Any prospective bidder, offer, or contractor or subcontractor who is aggrieved in connection with the solicitation of this contract may protest to Owner in accordance with Section 11-35-4210 of the SC Code of Laws, within 7 days of the date of issuance of the Intent to Award.

Owner's Rights: The Owner reserves the right to waive any informality or to reject any or all bids.
